REGULATIONS

1. The Nationwide Conference of Electronic Communication Operators is held by Polish Foundation for Development of Electronic Communication PIKSEL on commission of Polish Chamber of Electronic Communication.

2. For the purposes of these Regulations, the following terms are understood:

Conference	The Nationwide Conference of Electronic Communication Operators held between 20 and 22 May 2019 in Sheraton Hotel in Sopot,
PIKE	Polish Chamber of Electronic Communication,
Organiser	Polish Foundation for Development of Electronic Communication PIKSEL,
Reporting Entity	a person, legal entity or organizational unit without legal personality, which the law grants legal capacity, which reports Participants,
Regulations	this regulations,
RODO	Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46 / EC (general regulation on data protection),
Participant	a person reported to participate in the Conference.

3. Taking part in the Conference is subject to accreditation payment. The amount due will depend on the participant's status.

a) For Members of The Polish Chamber of Electronic Communication (PIKE Members) :

- 1 200,00 PLN net + 23% VAT, i.e. 1 476,00 PLN gross until April 19th 2019 up to 11:59 PM,
- 1 500,00 PLN net + 23% VAT, i.e. 1 845,00 PLN gross from April 20th 0:00 AM;

b) For Cable Operators not PIKE Members:

- 1 500,00 PLN net + 23% VAT, i.e. 1 845,00 PLN gross until April 19th 2019 up to 11:59 PM,
- 1 800,00 PLN net + 23% VAT, i.e. 2 214,00 PLN gross from April 20th 0:00 AM.

c) For all remaining subjects:

- 2 000,00 PLN net + 23% VAT, i.e. 2 460,00 PLN gross until April 19th 2019 up to 11:59 PM,
- 2 300,00 PLN net + 23% VAT, i.e. 2 829,00 PLN gross from April 20th 0:00 AM.

d) For subjects for 8th Forum of Local Televisions

- 750,00 PLN net + 23% VAT, i.e. 922,50 PLN gross until April 19th 2019 up to 11:59 PM,
- 900,00 PLN net + 23% VAT, i.e. 1 107,00 PLN gross from April 20th 0:00 AM.

4. Once the accreditation payment has been made, PIKE Member and all remaining subjects will be allowed to take part in the debating panel discussions, exhibition, meetings, workshops and accompanying events. The payment also includes meals that will be served during the Conference.

5. The above-mentioned deadlines shall be deemed met if one will satisfy them by filling in a complete form referred to in section 4 of this Regulation.

6. In order to enter into the Conference Participation (Accreditation) Agreement, it is required to fill in the entry form available at www.konferencjepike.pl, **no later than on May 17, 2019**. The Organizer's IT system will then automatically send a confirmation of application to the Organizer. Within a few days from the date of acceptance of the application, the Organizer shall issue an electronic pro forma invoice (in .pdf format) and send it to the e-mail address provided by the Participant in the entry form.

7. The agreement for accreditation will be reached when the Organizer confirms that he has received the application. The Organizer reserves the right to cancel the booking, if the charge is not paid within 7 days after the delivery of the pro forma invoice.

8. The Participant may withdraw from participating in the Conference and will not incur any expenses in this regard, provided that they send a declaration of withdrawal via electronic mail at akredytacje@pike.org.pl, no later than on 29 April 2019 until 11:59 PM. The deadline set in the preceding sentence is the date and time of receipt of the declaration of withdrawal (recording it in the inbox) by the Organizer. In the event of withdrawal from participation in the Conference without incurring any charges, the Entity shall be released from the obligation to pay the fee, and if the Entity has already paid the fee, it shall be subject to a refund made within 7 days from the submission of the declaration. The declaration of withdrawal should be made as per the template sent to the Entity together with the confirmation of application and available on the website www.konferencjepike.pl in the "Accreditation" tab. The statement shall be made in writing, scanned and then sent to the Organizer via e-mail.

9. Should the declaration of withdrawal be sent after the deadline set in Article 8 of the Regulations, i.e. **on 30 April 2019, 00:00 AM, and later**, the Organizer shall have the right to demand the accreditation fee from the Enrolling Entity in the amount specified in point 3 of the Regulations, and if it has been paid earlier, it has the right to keep the accreditation fee received. The right to claim the accreditation fee or to keep the accreditation fee received from the Enrolling Entity remains valid even in the event of failure to attend the Conference by the Participant the participation of whom has been revoked by a declaration submitted after the deadline specified in point 8 of the Regulations.

10. Changing the reported person to another is possible by May 17th 2019 inclusive. In order to do so one must write an e-mail to the Organizer. It should be submitted to the Organizer at akredytacje@pike.org.pl.

11. Obtaining the accreditation doesn't authorize anyone to conduct advertising or marketing activity in the course and at the venue of the Conference or referring to its course. The Organizer is entitled to make demand for payment of the contractual penalty for every case of action violating the rules determined in the first sentence. This fine will be equal to double the payment for services identical or similar to the ones that have been exploited by the participant. The right to make demand for payment of the contractual penalty isn't excluding the possibility of seeking compensation that exceeds its height.

12. The Organizer reserves the right to make changes to the Conference timetable as long as it doesn't affect the Conference's character.

13. The accreditation payment doesn't include costs of accommodation. We strongly advise to reserve the hotel rooms in advance, for their number is limited.

14. The following terms and conditions shall govern the rules of granting accreditation solely to the persons whose names were submitted by entities who are engaged in economic or professional activity in their own right and within the scope directly associated with this activity (entrepreneurs).

15. Concluding the accreditation agreement with other persons (consumers) is available solely in the Organiser's registered office (ul. Przemysłowa 30, 00-450 Warsaw, Poland), only upon previous scheduling the date with the Organiser. The date of concluding the agreement may be scheduled in a way convenient to the Consumer, especially via e-mail (akredytacje@pike.org.pl), by telephone (+48 22 696 65 31) or via traditional mail to the address indicated above.

16. If the Conference does not take place for the reasons attributable solely to the Organiser, the Organiser shall immediately refund the amount paid by the participants to their bank accounts.

17. If the Conference does not take place for the reasons beyond the Organiser's control, i.e. "force majeure" (e.g. flood, hurricane, snowstorm, etc.), the Participant shall not be entitled to any compensation or refund of any fees associated with participation in the Conference, nor to any compensation or refund of any fees related to additional services ordered by the Conference participants from the Organiser.

18. Any disputes that might arise out of participation in the Conference shall be resolved by the common court of applicable jurisdiction for the Organiser's registered office.

20. In matters not regulated by these terms and conditions, the provisions of the Civil Code shall apply.

21. The Conference is a closed event and shall not be treated as a mass event within the meaning of the Act of 23 March 2009 on mass events security (Polish Journal of Laws from 2009 no. 62, item 504).

22. The Organiser shall not be responsible for the items belonging to the Participants that may be lost, destroyed or stolen during the Conference.

23. The Participants shall bear full financial responsibility for any damages they make both on the premises where any kind of activity associated with the Conference is carried out, as well as in the places of accommodation.

24. The Organiser declares that he is the personal data administrator within the meaning of the RODO and informs that the personal data of the Participants obtained in the registration process, settlements or during the Conference are processed on the basis of the consent obtained or in relation to the Organiser's legitimate interest resulting from the organization's

obligation Conference, in accordance with art. 6 par. 1 lit. f) RODO. The Organiser declares that for the processing of data, he uses means of their protection in accordance with art. 32 RODO. The Organiser informs that the received personal data may be transferred to entities cooperating in the organization of the Conference, including companies preparing materials necessary for its organization. The personal data processed will be stored until the expiration of the period of limitation of claims resulting from the agreement on participation in the Conference (for accreditation) increased by one year. Participants and Reporting Entities have the right to rectify personal data, delete or limit processing, object to processing, transfer data, submit a complaint to the supervisory body and withdraw consent to the processing of personal data. Providing personal data is not obligatory, but making it available is necessary to conclude an agreement on participation in the Conference (for accreditation).

25. By submitting the enrolment form, the Participant agrees to recording and photographing of the Participant's image and to distribution of such recordings and photos by PIKSEL for promotional and marketing purposes. The aforementioned rule shall be applicable in the case where the Participant is filmed or photographed while participating in the Conference, as a part of a public event, in the vicinity of the host, during the workshops or when they willingly agree to give an interview in front of a camera or when they pose for a photo.
